After having a successful accounting firm and running a successful \$300,000 motel, Don's lust for alcohol and gambling destroyed them both.

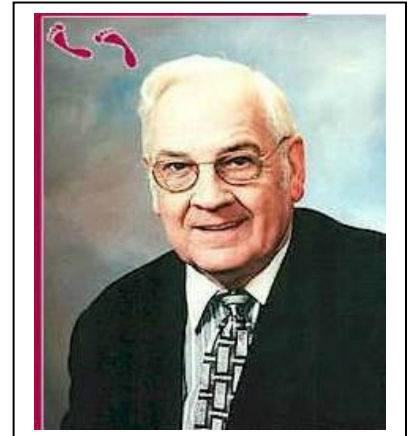
