Author, artist, sportsman, musician, Christian motivational speaker, and jewel thief. Murf gained worldwide notoriety in 1964 for the jewel robbery of the century when he and a partner stole the Star of India, the largest Star Sapphire in the World, from the American Museum of Natural History.

As the result of that caper, as well as other serious crimes, Murf spent 21 years in New York and Florida prisons. In 1986, he was released from prison on life parole. In 2000 his parole was completely terminated.

How did Murf get from a life of crime ending in lengthy incarceration to becoming the International Director of the largest Evangelical prison ministry in the world? Come hear this amazing testimony of how the destiny that God planned for you will come to pass regardless of how far you run – sometimes even having to go into the "pit" to learn your true value and calling.
